Installation Experience Requirements:

**minimum of 5 projects**  
and a  
**minimum of 10,000 sq. ft.**

For example:

- 2 projects totaling 20,000 sq ft does not meet the requirements
- 9 projects totaling 8,000 sq ft does not meet the requirements
- 5 or more projects totaling 10,000 sq ft or more does meet requirements

- Installation experience can be taken from any period of time that a person has been installing. Installers can go back as many years as needed in order to fulfill the requirements.
- Installation experience refers to onsite participation in the installation of concrete pavers. Do not include any projects on which work has not yet begun, or for which you were not an on-site participant in the installation.
- Please note that your installation experience needs to be submitted only once. You will not be required to submit this application again.
- The Record of Completion received for passing the Concrete Paver Installer course does not expire, so if you do not currently meet the minimum installation experience requirements, you can wait until you do meet them, and submit your application at that time.
- If you do not have contact information readily available for a project, you may leave the reference contact information column blank. Please note: if you are audited, you must supply contact information for a reference for each project listed on this form.
